Net Inclusion, NDIA's annual digital inclusion conference was moved online during the pandemic. NDIA produced two online Net Inclusion Webinar Series in FY21 - offering a total of 17 panel sessions covering different topics. These webinars had an average of 340 registrations and 100 streaming views. These webinars were free to the public and are still available for viewing.

NDIA is an affiliate-based organization of digital inclusion programs. NDIA gained 200 Affiliates in FY21, now totaling over 600. NDIA hosts and manages a large community listserv of over 1200 members. With the support of Working Groups (members of our community), NDIA created/offered the following free resources: the "digital navigator model" webpage, weekly community calls, Free & Low-Cost Internet Offers list, Worst Connected Cities of 2019 report, Digital Inclusion Trailblazers 2021, and countless informational blog posts and webinars.

NDIA builds awareness of the barriers and solutions to digital equity by participating in partner's webinars, educating policymakers and responding to media requests. NDIA created a webpage for the Emergency Broadband Benefit to assist in educating the community about resources available, NDIA had 136 media mentions and features, and staff were interviewed as digital inclusion experts at approximately 140 events. Notably, Angela Siefer testified at the State Senate Committee on Reimagining Massachusetts and joined a panel at the G7.
